CANUCKS FOR KIDS FUND SIGNED JERSEY CONTEST (the "Contest")

RULES AND REGULATIONS

THIS CONTEST IS BROUGHT TO YOU BY VANCOUVER CANUCKS LIMITED PARTNERSHIP ("VCLP") IN COOPERATION WITH CANUCKS FOR KIDS FUND ("CFKF"). NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO PARTICIPATE IN THE CONTEST YOU MUST READ AND AGREE TO THESE RULES AND REGULATIONS. (1) CONTEST PERIOD:

The Contest will begin at 12:00 PM (Pacific Time) on November 7, 2023 and ends at 7:00 PM (Pacific Time) on December 21, 2023 (the "Contest Period"). For the purposes of this Contest, the following time periods are organized into "Road Trips", for each of which there will be a prize draw as detailed in Section 5 below:

- Road Trip #1 begins at 12:00 PM (Pacific Time) on Tuesday, November 7, 2023 and ends at 6:00 PM (Pacific Time) on Sunday, November 12, 2023
- Road Trip #2 begins at 12:00 PM (Pacific Time) on Tuesday, November 21, 2023 and ends at 9:00 PM (Pacific Time) on Saturday, November 25, 2023
- Road Trip #3 begins at 12:00 PM (Pacific Time) on Friday, December 15, 2023 and ends at 7:00 PM (Pacific Time) on Thursday, December 21, 2023

(2) ELIGIBILITY:

In order to be eligible to win a prize, you must be a resident of the Province of British Columbia, at least 19 years of age, and must not be (and no member of your immediate family shall be) an employee of VCLP or any of its affiliates which collectively with VCLP operate as Canucks Sports & Entertainment (hereinafter "CSE") or CFKF or any affiliate of the foregoing. (3) HOW TO ENTER:

There are two methods to enter the Contest:

- 1. Vancouver Canucks 50/50 Method:
 - i. During a Road Trip, purchase a CFKF Vancouver Canucks 50/50 ticket using a web browser at www.canucks.com/5050 or using the Canucks app, and opt-in to entering the Contest during the purchase process. You will receive one (1) entry into the applicable Road Trip prize draw. There is no limit to the number of entries per person by this entry method.
- 2. Letter Method (no purchase necessary):
 - i. To enter the Contest without making a 50/50 purchase, please mail a handwritten letter requesting a free entry along with your legal name, date of birth, email, mailing address and cell phone number to: ATTN: Canucks for Kids Fund Road Trip Contest, 89 W. Georgia Street, Vancouver, BC V6B 0N8. If your letter is received by VCLP prior to the end of the Contest Period, you will receive one (1) entry for the next Road Trip prize draw. There is a limit of one entry per person to the Contest by this entry method.

Potential winners may be required to provide VCLP with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.

(4) PRIZES:

There will be three (3) prizes to be won (one for each Road Trip prize draw), each consisting of one (1) autographed Vancouver Canucks Home Jersey. The approximate retail value of each prize is \$400. All prizes will be awarded and are provided "AS IS" without warranty of any kind, express or implied.

(5) WINNER SELECTION:

The prize winner(s) will be randomly selected on or around the end of each Road Trip from all qualified entries submitted during such Road Trip. Any potential winner will be contacted via phone or email within the first week following their random selection. Non-winning entries will not carry over from one Road Trip prize draw to the next. Odds of winning a prize depend on the number of entrants who participate in the Contest during each Road Trip. No entrant is eligible to win more than one prize.

A selected entrant will be required to correctly answer, unaided, a time-limited mathematical skill-testing question to be administered by VCLP and to confirm his/her eligibility.

A selected entrant must also agree to sign and return VCLP's standard Declaration and Release Form before being eligible to receive a prize.
